## TRANSPORTATION REQUEST TO NON-PUBLIC SCHOOLS 2022-2023

New York State Education Law requires parents requesting transportation for their children to non-public schools for **September 2022, must apply in writing by Friday, April 1, 2022.** Please complete the form below and file it promptly with the Transportation Department, Attention: Transportation Supervisor, 81 Lake Avenue, Deer Park, NY 11729. Even if you have only applied for admission and have not yet been accepted, you should file the request. Failure to apply could lead to your child not receiving the desired transportation and or textbooks for the school year. **Should your plans change after filing this request, notify the Transportation Department immediately at 631-274-4060.**

**The Deer Park Union Free School District reserves the right to request verification of legal residence.**

**PLEASE NOTE:** On days public schools are scheduled to be closed in accordance with the school district calendar, the district is **not** obligated to transport to non-public schools. **Under no circumstances will transportation be provided on legal holidays or Saturdays.**

As you are aware New York State Education Law requires you to submit in writing your request for transportation services for your child if he/she will be attending a non-public school for the upcoming 2022-2023 school year on or before **April 1, 2022**. Enclosed is a copy of the district transportation form which must be completed. **Please complete the form and mail it to Deer Park Transportation, 81 Lake Avenue, Deer Park, 11729 or email it to [Camodeo.K@deerparkschools.org](mailto:Camodeo.K@deerparkschools.org) on or before April 1st.**

The Office of Central Registration has your child's registration information on file. If you have **moved within Deer Park and have a new address**, you need to email proof of the new address to [centralreg@deerparkschools.org](mailto:centralreg@deerparkschools.org). All new Kindergarteners must email proof of residence.

In the event you fail to comply with our district's non-public school registration process your child **will not** be issued a transportation route for the upcoming school year and your child's textbooks will be placed "on hold" by Eastern Suffolk BOCES until the district registration paperwork is received.
