Proof Age

When available, a certified birth certificate or record of baptism (including a certified transcript of a foreign birth certificate or record of baptism) giving the date of birth will be used to determine a child’s age. If these documents are not available, a passport (including a foreign passport) may be used to determine a child's age. If a passport is not available, the District will consider other documentary or recorded evidence in existence for at least two (2) years to determine a child's age. Other evidence may include, but not be limited to, the following:

- (1) Official driver’s license;
- (2) State or other government-issued identification;
- (3) School photo identification with date of birth;
- (4) Consulate identification record;
- (5) Hospital or health records;
- (6) Military dependent identification card;
- (7) Documents issued by Federal, State, or local agencies (e.g., local social service agency, Federal Office of Refugee Resettlement);
- (8) Court orders or other court-issued documents;
- (9) Native American tribal document; or
- (10) Records from non-profit international aid agencies and voluntary agencies.

- Valid Photo ID (*Driver's license, Learner's permit, Non-driver photo ID*)
- If not the natural parent, you may submit one (1) other form of documentation, including, but not limited to, the following: Court issued legal guardianship papers, Court order granting custody, Court appointment as foster parent, adoption papers, documents issued by Federal, State or local agencies, parental or custodial affidavit, or other documentary or recorded proof.
